Public Comment

Neil Strack – Thanked the Architects and the Tier Two Facilities Committee regarding their work with Dr. Howard. He is appreciative of the process. Are other contingencies in the numbers?

- Yes – multiple contingencies are in place. A more detailed breakdown will be provided in the future.

Dr. Lawrence Richards is in favor of a three story building so there can be more playground space. Can some pieces be taken out and used in a new building?

- Yes, elements can be used from the old building and incorporated into the new building design. Costs could be minimal depending on what is used. The District will look at what can be saved and the costs associated.

Thoughts and Comments From Committee Members

- Would like Dr. Howard's Faculty, Staff and PTA's input as to what they would prefer (2 story vs. 3 story) and how that would affect student safety and supervision.
- Get feedback from Dr. Howard neighborhood.
- Prioritize buildings with a dollar amount attached to each project.
